# RESOLUTION TO SET A HEARING TO CONSIDER DISCONTINUANCE OF A NUMBER OF STREETS AND ALLEYS IN WAUKAU IN THE TOWN OF RUSHFORD

The Town Board of the Town of Rushford, Winnebago County, Wisconsin, by this resolution, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

A public hearing to discuss a proposed action to discontinue a number of streets and alleys in Waukau in the Town of Rushford shall be held as provided in accordance with the following Notice of Hearing.

The town clerk shall publish the following Notice of Hearing as a class 3 notice under Chapter 985, Wis. Stats., give notice to the Department of Natural Resources pursuant to Section66.1006, Wis. Stats., and the town clerk shall cause the Notice of Hearing to be served on the owners of all of the frontage of lots and lands abutting upon the public way sought to be discontinued in the manner provided for the service of summons in Circuit Court at least 30 days before the hearing, except that when service cannot be made within the town, a copy of the notice shall be mailed to the owner's last-known address at least 30 days before the hearing:

A public hearing will held by the Town Board of the Town of Rushford at the Rushford Town Hall located at 3413 County Road K, Omro, WI 54963, on December 7, 2016, at 7:00p.m., to discuss a proposed action to commence discontinuance of a number of streets and alleys in Waukau described on the attached Exhibit A and B, which was initiated by introduction of a resolution of the Town Board of the Town of Rushford under Section 66.1003, Wis. Stats.

The town clerk shall file in the Office of the Register of Deeds for Winnebago County, Wisconsin, a Lis Pendens related to the proposed discontinuance of public way.

The town clerk shall properly post or publish this resolution as required under Section 60.80, Wis. Stats.
